


AFFIDAVIT

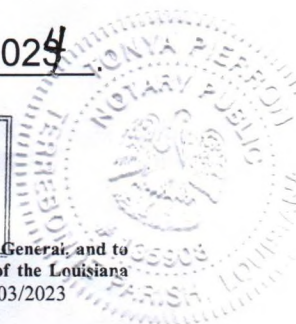
