Accordingly, Management has not classified the difference between its assets and liabilities based on the existence or absence of donor-imposed restrictions. In addition, Management has not reported the changes in each of those classes of net assets in the accompanying financial statements.

Management has elected to omit substantially all of the disclosures ordinarily included in the financial statements prepared in accordance with the tax basis of accounting. If the omitted disclosures were included in the financial statements, they might influence the user's conslusions about the Organization's assets, liabilities, net assets, revenues, and expenses.
