## AFFIDAVIT

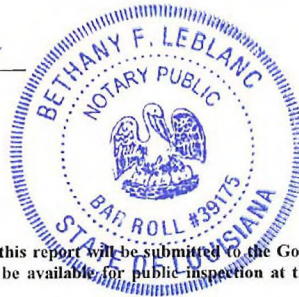
