Boards, Commissions, and Like Entities Annual Report to the Legislature as of June 30, 2021

Summary

The purpose of this report is to summarize information provided to the Division of Administration (Division) by boards, commissions, and like entities (Boards). Louisiana Revised Statute (R.S.) 24:513.2(E) requires the Legislative Auditor to submit annually to the Legislature a report containing summary financial information and personnel data on Boards included in the database. The statute provides for the Legislative Auditor to report findings and recommendations resulting from any analysis of the information. Our findings and recommendations are categorized as follows:

- **Boards & Commissions Website** - The Boards & Commissions website is located at <https://wwwcfprd.doa.louisiana.gov/boardsandcommissions/selectBoard.cfm>. The accuracy of the information available is solely dependent upon the timeliness and accuracy of the Boards' data entry.
- **Number of Boards Reported** - As of June 30, 2021, the website contains information on 482 Boards, which is a net increase of seven from the previous year.
- **Boards Providing No Response** - We identified four Boards that did not respond to our request for personnel data and financial information. The Division sent notices of noncompliance to the respective legislative committees as required by R.S. 49:1301. Three of the Boards also failed to respond to our request in the prior year. The Legislature may wish to consider taking action against Boards that fail to comply with the reporting requirements in state law.
- **Inactive Boards** - We identified 12 inactive Boards that were not fulfilling their established functions. Ten of these inactive Boards were also identified as inactive in the prior year. We recommend that the Legislature consider abolishing these Boards or taking other actions (additional legislation, appropriations, or board appointments) to assist them in fulfilling their established function.
- **Board Activity** - We identified 36 Boards that reported their status as active but have not reported any meeting notices or minutes subsequent to December 31, 2017. Also, five of these Boards have no board members identified on the website. We recommend that the Division continue to work with these Boards to ensure they are appropriately reporting their status and complying with the reporting requirements in state law to make their meeting notices and minutes available on the website.

- **Board Per Diems, Salaries, and Travel Expenses** - For fiscal year 2021, Boards budgeted approximately \$1.3 million for Board member per diems, \$2.5 million for Board member salaries, and \$1.9 million for Board member travel expenses.

Boards & Commissions Website

R.S. 49:1301 requires the Commissioner of Administration to establish and maintain a website containing information on Boards: <http://wwwcfprd.doa.louisiana.gov/boardsandcommissions>.

The accuracy of each Board's self-reported information available on this website is solely dependent upon the timeliness and accuracy of each Board's data entry. As a result, anyone attempting to access information about current budgets or expenses for a specific Board may instead retrieve information that is outdated or inaccurate.

We recommend that the Division continue to work with our office regarding the identification of Boards to be added or removed from the database and the form and content of the database fields. We will also meet with the Division periodically to monitor updates and improvements to the website database.

Number of Boards Reported

As of June 30, 2021, the website contains information on 482 Boards (see Appendix B), which is a net increase of seven from the previous year. This net figure reflects the addition of 12 Boards and the removal of five Boards.

The 12 boards added include seven new Boards created during the 2020 legislative sessions, four new Board created by Executive Order, and one existing Board not previously included in the database. Boards added to the database during the year ended June 30, 2021, are as follows: Advisory Commission for Louisiana's Energy, Environment and Restoration; Advisory Council on Student Behavior and Discipline; Broadband for Everyone in Louisiana Commission; Council on the Children of Incarcerated Parents and Caregivers; Cybersecurity Education Management Council; Governor's Advisory Council on Rural Revitalization; Governor's Advisory Task Force on Atchafalaya River Basin Restoration and Enhancement; Governor's Task Force on Murdered and Missing Indigenous Women and Girls; Louisiana Tax Institute; New Orleans Public Belt Railroad Commission; Streamlining Government Commission; and Vernon Parish Economic Development District.

The five Boards removed include four that were abolished in prior-year legislation and one Executive Order board that had fulfilled its purpose and disbanded. Boards removed from the database during the year ended June 30, 2021, are as follows: Act 420 Task Force (Medicaid Fraud Detection and Prevention Initiatives); Language Equality and Acquisition for Deaf Kids (LEAD-K) Task Force; Military Hall of Fame and Museum Governing Board; Protecting Health Coverage in Louisiana Task Force; and Work Out Now: WON Louisiana Legislative Commission.

The effects of the laws enacted during the 2021 Regular Legislative Session are not reflected in the database as of June 30, 2021. Any new or abolished Boards resulting from the 2021 Regular Legislative Session will be added or removed prior to the 2022 reporting period.

Boards Providing No Response

R.S. 24:513.2(F) directs all agencies, boards, commissions, and departments of the state and its political subdivisions to furnish information and reports as requested by the Legislative Auditor to fulfill his responsibilities. All Boards were requested to provide contact information, membership information, and statutory or legal authority relative to the entity.

R.S. 39:1335 and 1336 require licensing agencies to provide summary and detailed information pertaining to actual and budgeted revenues by source, expenditures by category, and fund balances; performance indicators; and certain general information pertaining to the Board and its authority and functions.

All other Boards were requested to provide similar information, except that the financial and budget information was requested in summary form only, and information pertaining to performance indicators was not requested.

As of June 30, 2021, the following four Boards did not respond to our request for personnel data and financial information. Three of these Boards also failed to respond to our request in the prior year.

1. Bi-State Corridor Commission *

Purpose or function:	Provide an information forum on the construction, expansion, improvement, or extension of a route designated U.S. 371, including the four-lane improvements or any portion thereof within the boundaries of the district; the construction of bridges, overpasses, causeways, underpasses, traffic circles, interchanges, and landscaping relating thereto; and the long-term economic/ industrial development and tourism development of the corridor area.

3. Housing and Transportation Planning and Coordinating Commission *

Purpose or function:	Advise the Louisiana Housing Corporation in coordinating the integration of planning and spending by local governments, parish and municipal governing authorities, redevelopment authorities, and the Department of Transportation and Development on housing and transportation needs.

4. Iberia Parish Levee, Hurricane, and Conservation District Board of Commissioners *

Purpose or function:	To understand the dynamics of flood protection and tidal surge needs specific to Iberia Parish in order to implement a plan for such protection in conjunction with neighboring Parishes and to determine and identify funding sources to implement said plan.
Year created:	2010

Date of last meeting:	July 23, 2020

A joint letter from the Legislative Auditor and the Commissioner of Administration requesting information was mailed to all Boards identified in our report (Appendix B). Numerous requests to the Boards listed above were made by the Division's staff to submit the requested information in the database.

In accordance with R.S. 49:1301, the Division sent notices of noncompliance to each Board that failed to respond to its requests. In addition, notices of each entity's failure to respond were sent to the state departments of which the entity is a part, the Senate Committee on Senate and Governmental Affairs, the House Committee on House and Governmental Affairs, and the oversight committees for each Board. The Legislature may wish to consider taking action against Boards that fail to comply with the reporting requirements in state law.

Inactive Boards

The following 12 Boards were created by the Legislature prior to the 2020 Legislative Session and were inactive, not fully organized, or disbanded as of June 30, 2021, due to the reasons below which were obtained from the Board's representative. Ten of these Boards were also inactive during the prior year. Because these Boards are not fulfilling their established functions, the Legislature should consider abolishing them or taking other actions (additional legislation, appropriations, or board appointments) to assist them in fulfilling their established function.

1. Advisory Subcommittee of the Accountability Commission

Reason for inactivity provided by Board representative:	HB 555 was filed in 2021 Regular Session to repeal the statute relative to this subcommittee, which was subject to several reporting deadlines that have passed.

Purpose or function:	Provide for the following: a unified and comprehensive response to housing shortages and other indirect effects of hurricanes Katrina and Rita upon the city of Lafayette; the general and economic welfare of the city through housing, commercial, office, hospitality, recreation, education, infrastructure and utility capacity, manufacturing, industrial, research, retail or other activities which will create or retain jobs, maintain or diversify industry, including new or emerging technologies, or maintain or increase the tax base; the improvement of conditions of deteriorated physical development, slow economic growth, and eroded financial health of the public and private sectors; the control, abatement, and prevention of pollution to protect public health and safety, and the development and use of indigenous and renewable energy resources; and assistance to nonprofit and governmental entities in support of health, educational, charitable, community, cultural, agricultural, consumer, or other services benefitting the citizens.

R.S. 49:1302 requires notices and minutes of board meetings to be included on the Boards & Commissions website. The Division has requested all Boards to either post their meeting notices and minutes directly to the Boards & Commissions website or provide a link to meeting notices and minutes that are posted on the Board's own website.

Based on our review of the 464 Boards with a reported status of active, we identified 36 Boards as listed below that have not reported any meeting notices or minutes subsequent to December 31, 2017. Also, five of these Boards have no board members identified on the website. We recommend the Division continue to work with our office and these Boards to ensure all Boards are appropriately reporting their status and complying with the reporting requirements to make their meeting notices and minutes available on the Boards & Commission website.


