


AFFIDAVIT

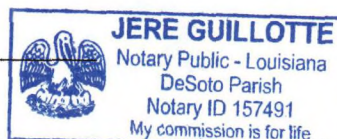
