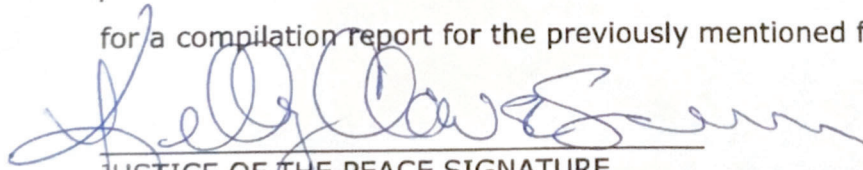

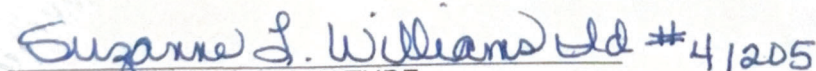
AFFIDAVIT
