# Louisiana City Marshals and City Constables

#### **Background**

This report provides information about Louisiana City Marshals and City Constables, including duties, compensation, and staffing. Both the title of "marshal" and "constable" refer to the executive officers of the city courts in Louisiana. The title of "marshal" is used in all parishes except East Baton Rouge and Orleans, which instead use the title "constable." State law1 requires that each city court have a marshal or constable who must be elected at the congressional election and serve a term of six years. There are 47 City Marshals and City Constables in Louisiana. State law<sup>2</sup> states that the provisions related to City Marshals and their deputies must apply to City Constables and their deputies. We generally use the term City Marshal throughout this report.

State law<sup>3</sup> establishes qualification requirements for City Marshals, requiring them to be residents of the city court jurisdiction they serve in and to submit a bond to a city judge before beginning their duties to provide assurance for the faithful performance of their duties. While state law does not specifically mandate that City Marshals be Peace Officer Standards and Training (POST) certified, state law<sup>4</sup> requires that any person exercising the authority of a peace

## Why We Compiled This Informational Brief

Because of legislative interest in the City Marshals and City Constables, we gathered information and statistics relevant to their duties, compensation, and staffing.

Informational briefs are intended to provide more timely information than standardsbased performance audits. While these informational briefs do not follow all Governmental Auditing Standards, we conduct quality assurance activities to ensure the information presented is accurate. We met with the Louisiana City Marshals and City Constables Association and incorporated feedback from individual City Marshals and City Constables throughout this informational brief.

officer (i.e., making arrests and preserving the peace) must be POST certified.<sup>5</sup>

#### What We Found

In general, compensation of City Marshals consists of salary, civil fees authorized by state law, and additional compensation authorized either by state law or by the governing authorities of either the city, the parish, or both and ranges from a low of \$5,400 to a high of \$469,585 in 2023.<sup>6</sup> State law either sets minimum salaries<sup>7</sup> for City Marshals or

Marshals (except New Orleans

for services rendered in civil
matters. These services include,
collecting/processing/dispersing
garnishments and serving civil
court papers. However, state law
limits the amount of fees that
some city marshals are entitled
to receive.

In addition, state law<sup>9</sup> specifies fees that City Marshals and City Constables<sup>10</sup> are entitled to receive as additional compensation pursuant to services rendered in civil matters (see text box to left). Various state law provisions<sup>11</sup> also authorize different City Marshals to receive additional compensation in terms of travel expenses, annual vacation, etc. Exhibit 1 provides total compensation each City Marshal received during fiscal year 2023 from highest to lowest, while Appendix B provides a profile for every City Marshal and City Constable with a breakdown of their total compensation.

State law<sup>12</sup> authorizes City Marshals to appoint Deputy Marshals; requires governing authorities of the city, the parish, or both wherein the court is located to establish the compensation for Deputy Marshals; and authorizes the City Marshal to use his office funds to pay compensation to Deputy Marshals in excess of the fixed amounts.

The City Marshals' offices are also authorized by state law<sup>13</sup> to provide benefits to the City Marshal and its employees in the form of health insurance or other related benefits. City Marshals and their employees may also be eligible for retirement benefits<sup>14</sup> if the cities they are located in have an agreement with the Municipal Employees Retirement System (MERS). Currently, 25 of 47 (or 53.2%) City Marshal's offices are members of MERS.<sup>15</sup> In addition, POST-certified City

Marshals and Deputy Marshals are eligible for State Supplemental Pay, per the State Constitution<sup>16</sup> and state law.<sup>17</sup>

Staffing in each City Marshal's office depends on how many full-time, part-time and reserve Deputy Marshals they employ and ranges from a low of no full-time employees to a high of 43 full-time employees as of June 30, 2023. Specifically, 41 out of 47 (or 87.2%) City Marshal's offices employ anywhere from 1 to 43 full-time employees (FTE), while 35 out of 47 (or 74.5%) City Marshal's offices employ anywhere from 1 to 8 part-time employees (PTE). In addition, 27 out of 47 (or 57.4%) City Marshal's offices also have anywhere from 1 to 55 Reserve Deputies. 18 Exhibit 2 below provides staffing information for each City Marshal's office.

Each City Marshal's office differs based on what additional law enforcement or community functions they perform, such as operating city jails or conducting radar-based speed enforcement. City Marshals have the same powers and authority as a Sheriff to enforce the laws and ordinances of the state, parish, and city within their jurisdiction, and they can exercise these powers without orders from the City Court or consent from the City Mayor. While all City Marshals execute City Court orders as their primary duty, some City Marshals also provide additional law enforcement services. For example,

- The Baton Rouge City Constable's Office operates the city jail.
- The Lafayette City Marshal's Office has a School Resource Officers Division that is responsible for providing a safe learning environment for students and staff, and for administering the Drug Abuse Resistance Education (DARE) program.
- The Shreveport City Marshal has a Training Division that is responsible for training all the deputies of the Shreveport City Marshal's office. In addition, this division is responsible for fleet services, inventory, and the purchasing of supplies and equipment for the Marshal's office.
- The Bossier City Marshal's Office has a Probation Division that monitors defendants placed on supervised probation by Bossier City Court.
- The Oakdale City Marshal's office has a Patrol Division that conducts radar-based speed enforcement and writes citations.
- The New Orleans Second City Court Constable sponsors and donates its time, manpower and resources to a variety of community efforts, including: annual turkey giveaway to seniors at the Arthur Monday Center, co-hosting self-defense classes for women and children, etc.

State law<sup>20</sup> requires the cities in which city courts are located to provide and pay for expenses associated with the operation and maintenance of offices for judges, clerks, and city marshals. State law<sup>21</sup> also authorizes the city and parish to split the expenses for the operation and maintenance of these offices as the respective governing authorities may determine. However, in some cases, state law<sup>22</sup> specifies exactly how these expenses should be split between the city and the parish. For example, the expenses for the operation and maintenance of Ville Platte City Court and its offices must be split between the municipality of Ville Platte and Evangeline Parish, but in no event is the parish required to pay more to the court than the amount of revenues received by the parish from the court. In comparison, the expenses for the operation and maintenance of Leesville City Court and its

offices must be split equally between the city of Leesville and the police jury of Vernon Parish. In addition, state law<sup>23</sup> requires some cities, such as Lafayette and Shreveport, to furnish and maintain vehicles for use by the city marshal's offices.
