Notes to Financial Statements

(1) Summary of Significant Accounting Policies

A. Nature of Activities

The Judice Volunteer Fire Department, Inc. (the Organization) operates as a nonprofit corporation under the laws of the State of Louisiana. The primary purpose of the Organization is impeding, preventing, and extinguishing all types of destructive fires within or near the Town of Duson, Louisiana; supervising, directing, and controlling the proper care and use of all types of inflammable or combustible material found within the immediate area; acquiring and holding property for the purposes of the Organization and other related purposes.

B. Basis of Accounting

The financial statements of the Organization have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Net assets and revenues, expenses, gains and losses are classified based on the existence or absence of donor-imposed restrictions. Accordingly, net assets of the organization and changes therein are classified and reported as net assets without donor restrictions or net assets with donor restrictions.

Net assets without donor restrictions – Net assets that are not subject to donor-imposed stipulations.

Net assets with donor restrictions – Net assets subject to donor-imposed stipulations that will either (1) expire by incurring expenses satisfying the restricted purpose (purpose restricted), and/or the passage of time or other events (time restricted), or (2) will never expire (perpetual in nature). When a restriction expires, net assets with donor restrictions are reclassified to net assets without donor restrictions and reported in the statement of activities as net assets released from restrictions.

C. Property and Equipment

The Organization capitalizes all property and equipment, which has an expected useful life in excess of two years, and an acquisition cost of \$1,000 or more. Property and equipment are stated at cost. Depreciable assets are depreciated using the straight-line method over the estimated useful lives of the individual assets as follows:

Buildings and improvements	10 - 39 years
Equipment	5 - 10 years
Vehicles	10 Years

D. Cash and Interest-Bearing Deposits

For purposes of the statements of cash flows, the Organization considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash equivalents.

E. Concentration of Credit Risk

The Organization maintains cash balances at one financial institution, which may at times exceed federally insured limits. Accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000. At December 31, 2024, the Organization's cash balances were fully insured.

F. <u>Use of Estimates</u>

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

G. Functional Expenses

Expenses are charged directly to program or supporting services in general categories based on specific identification.

H. Donated Services

The Organization receives a significant amount of donated services from unpaid volunteers who assist in program services during the year. These donated services are not reflected in the statement of activities because the criteria for recognition under professional standards have not been satisfied; however, these services are valuable to the Organization's programs.

I. Revenue and Expense Recognition

The Organization receives grants, contributions, contract services and other miscellaneous revenues. Grant revenues are recognized only to the extent that related expenses have been incurred. Contribution revenues are recognized when the donor makes a commitment to give to the Organization. All contributions are considered to be available for unrestricted use unless specifically restricted by the donor. Contract service fees received from Lafayette Consolidated Government are earned annually representing the period over which the Organization satisfies the performance obligation. Expenses are recognized in the period incurred in accordance with the accrual basis of accounting.

(4) Compensation, Benefits, and Other Payments to Agency Head

The agency head, Troy Lopez, Fire Chief, received a salary of \$14,061 for the year ended December 31, 2024.

(5) Liquidity and Availability of Financial Assets

The Organization has \$186,886 of financial assets available within 1 year of the statement of financial position date to meet cash needs for general expenditures consisting of cash of \$186,886. There were no donor-imposed regulations within one year of the statement of financial position date. As part of the Organization's liquidity management, the Organization has a policy to structure its financial assets to be available as its general expenditures, liabilities and other obligations become due.

(6) Subsequent Event Review

The Organization has evaluated subsequent events through June 20, 2025, the date which the financial statements were available to be issued and determined that no events have occurred that require additional disclosure.
