We performed a compilation engagement with respects to the financial statements of St. Tammany Parish Recreation District 7, a component unit of St. Tammany Parish for the year ended December 31, 2018, in accordance with generally accepted accounting principles. We did not audit compliance with certain provisions of laws, regulations, contracts, and grant agreements and as such we do not express such an opinion on compliance. However, during the course of our engagement we noted the District was in noncompliance with the following.

#### **Filing of Compilation Report**

The District did not remit their compiled financial statements to the Louisiana Legislative Auditor within six months of their fiscal year end. The District is required to submit their compiled financial statements to the Louisiana Legislative Auditor in accordance with LRS 24:513. Not submitting their compiled financial statements within the prescribed timeline results in noncompliance with state statutes. We recommend the District submit their compiled financial statements to the Louisiana Legislative Auditor with their compiled financial statements to the Louisiana Legislative Auditor within the prescribed timeline results in noncompliance with state statutes. We recommend the District submit their compiled financial statements to the Louisiana Legislative Auditor within six months of their fiscal year end.

#### **Management's Response**

Our reports were late due to a change in board members and switching to another accounting firm. We now have all needed board members and have switched to another accounting firm. We anticipate being able to submit our 2019 compilation within the required statutory deadline.
