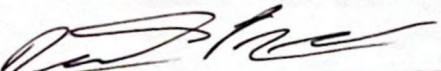

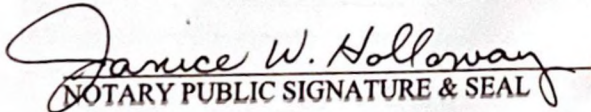
AFFIDAVIT

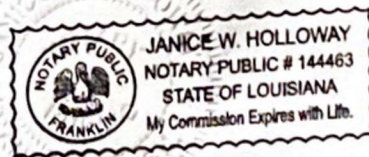
