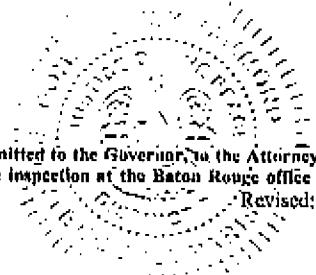
**AFFIDAVIT**
