Summary

The purpose of this report is to summarize information provided to the Division of Administration (Division) by boards, commissions, and like entities (Boards). Louisiana Revised Statute (R.S.) 24:513.2(E) requires the Legislative Auditor to submit annually to the Legislature a report containing summary financial information and personnel data on (1) Boards created by law or executive order that are made part of, or are placed in, the executive branch of state government and (2) local Boards that are specifically created by law. The statute provides for the Legislative Auditor to report findings and recommendations resulting from any analysis of the information. Our findings and recommendations are categorized as follows:

- **Boards & Commissions Website** - The Boards & Commissions website is at <https://wwwcfprd.doa.louisiana.gov/boardsandcommissions/selectBoard.cfm>. The accuracy of the information available is solely dependent upon the timeliness and accuracy of the Boards' data entry.
- **Trends** - This report identifies 472 Boards as of June 30, 2019, which is a decrease of five from the previous year.
- **Boards Providing No Response** - We identified seven Boards that did not respond to our request for personnel data and financial information. The Division sent notices of noncompliance to the respective legislative committees as required by R.S. 49:1301. Two of the seven Boards also failed to respond to our request in the prior year. We recommend that the Legislature take actions to require these Boards to comply with the law.
- **Inactive Boards** - We identified 17 inactive Boards that were not fulfilling their established functions. We recommend that the Legislature consider abolishing these Boards. Seven of the 17 inactive Boards were also identified as inactive in the prior year.
- **Board Per Diems, Salaries, and Travel Expenses** - For fiscal year 2019, Boards budgeted approximately \$1.3 million for per diems, \$2.0 million for salaries, and \$2.1 million for travel expenses.

Boards & Commissions Website

R.S. 49:1301 requires the Commissioner of Administration to establish and maintain a website containing information on Boards: <http://www.cfprd.doa.louisiana.gov/boardsandcommissions>.

The accuracy of each Board's self-reported information available on this website is solely dependent upon the timeliness and accuracy of each Board's data entry. As a result, anyone attempting to access information about current budgets or expenses for a specific Board may instead retrieve information that is outdated or inaccurate.

We recommend that the Division continue to work with our office regarding the form and content of the database fields to ensure information entered is properly maintained. We will also meet with the Division periodically to monitor updates and improvements to the website database.

Trends

This report identifies 472 Boards as of June 30, 2019 (see Appendix B), which is a decrease of five from the previous year. The decrease is attributable to four boards that were abolished through prior-year legislation or a statutory sunset provision and one board that did not meet the criteria for inclusion in the database. The effects of the laws that resulted from the 2019 Regular Legislation Session are not reflected in the Boards listed in the database as of June 30, 2019. Any new or abolished Boards resulting from the 2019 Regular Legislative Session will be added or removed prior to the fiscal year 2020 reporting period.

As noted below, the total number of Boards has fluctuated between 458 and 477 boards over the past five years.

Boards Providing No Response

R.S. 24:513.2(F) directs all agencies, boards, commissions, and departments of the state and its political subdivisions to furnish information and reports as requested by the Legislative Auditor to fulfill his responsibilities. All Boards were requested to provide contact information, membership information, and statutory or legal authority relative to the entity.

R.S. 39:1335 and 1336 require licensing agencies to provide summary and detailed information pertaining to actual and budgeted revenues by source, expenditures by category, and fund balances; performance indicators; and certain general information pertaining to the Board and its authority and functions.

All other Boards were requested to provide similar information, except that the financial and budget information was requested in summary form only, and information pertaining to performance indicators was not requested.

As of June 30, 2019, we identified the following seven Boards that did not respond to our request for personnel data and financial information. Two of these Boards also failed to respond to our request in the prior year.

A joint letter from the Legislative Auditor and the Commissioner of Administration requesting information was mailed to the Boards identified in our report. Numerous requests to the Boards identified above were made by the Division's staff to submit the requested information in the database.

In accordance with R.S. 49:1301, the Division sent notices of noncompliance to each Board that failed to respond to its requests. In addition, notices of each entity's failure to respond were sent to the state departments of which the entity is a part, the Senate Committee on Senate and Governmental Affairs, the House Committee on House and Governmental Affairs, and the oversight committees for each Board. The Legislature may wish to consider taking some action against Boards that fail to comply with the reporting requirements in state law.

Inactive Boards

The following 17 Boards were never fully organized; were disbanded with no plans to reorganize; were inactive; or had no funding prospects to undertake the functions for which they were established. Seven of these Boards were also inactive during the prior year. Because these entities are not fulfilling their established functions, the Legislature should consider abolishing them.

Board Per Diems, Salaries, and Travel Expenses

Of the 472 Boards listed in Appendix B, 132 reported budgeted payments for Board member per diem, salaries, and/or travel for fiscal year 2019, as listed in Exhibit 1 below. Of the remaining 340, seven failed to respond to the request for information, and the remaining 333 indicated no payments were budgeted for Board member per diem, salaries, or travel for fiscal year 2019. Boards will submit actual expenses from fiscal year 2019 during the fiscal year 2020 reporting period. Boards have until May 1, 2020, to enter fiscal year 2020 budgets along with fiscal year 2019 actual expenses in the database.
