We do not express an opinion, a conclusion, nor provide any assurance on these financial statements.

Management has elected to omit substantially all of the disclosures required by accounting principles generally accepted in the United States of America. If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the District's financial position, results of operations, and cash flows. Accordingly, the financial statements are not designed for those who are not informed about such matters.

The Southeast Bienville Water System, Inc. did not adopt the provisions of the Governmental Accounting Standards Board Statement No. 34 for the period ended June 30, 2024. The effects of this departure from generally accepted accounting principles has not been determined.
