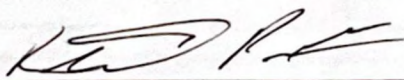

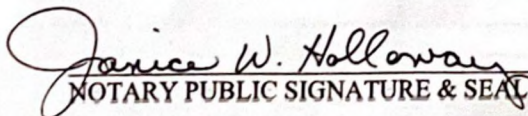
AFFIDAVIT

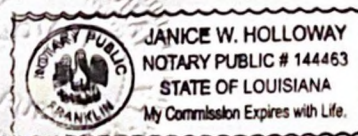
