**AFFIDAVIT**

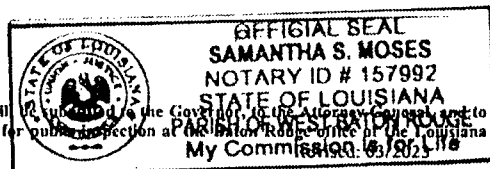
