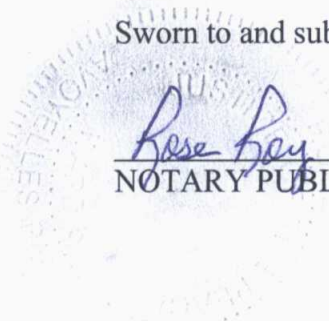
AFFIDAVIT
