If the omitted disclosures were included in the financial statements, they might influence the user's conclusions about the Corporation's assets, net assets, revenues and expenses. As provided for under the requirements of Louisiana Revised Statue 24:513, the corporation has not adopted the provisions of Governmental Accounting Standards Board Statement No. 34 for the year ended December 31, 2019. The effects of this departure from accounting principles generally accepted in the United States of America have not been determined.
