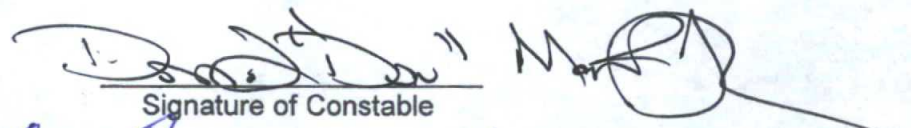

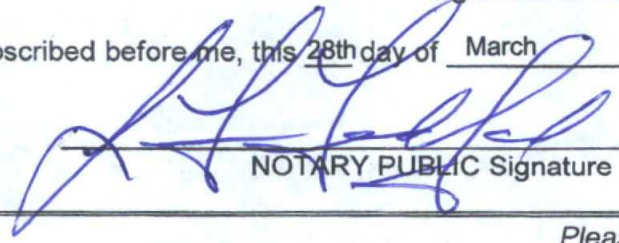
AFFIDAVIT

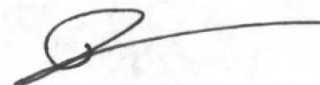

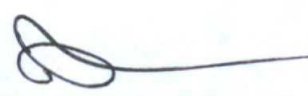
