Boards, Commissions, and Like Entities Annual Report to the Legislature as of June 30, 2016

Summary

The purpose of this report is to summarize information provided to the Division of Administration (Division) by boards, commissions, and like entities (Boards). Louisiana Revised Statute (R.S.) 24:513.2(E) requires the Legislative Auditor to submit annually to the Legislature a report containing summary financial information and personnel data on (1) Boards created by law or executive order that are made part of, or are placed in, the executive branch of state government and (2) local Boards that are specifically created by law. The statute provides for the Legislative Auditor to report findings and recommendations resulting from any analysis of the information. Our findings and recommendations are categorized as follows:

- **Trends** This report identifies 458 Boards as of June 30, 2016, which is a net decrease of 13 from the previous year. Although the total number of Boards has decreased by 34, or 6.9%, over the past five years, Louisiana still exceeds the number of Boards in other Southeastern states.
- **Boards Providing No Response** We identified four Boards that did not respond to our request for personnel data and financial information. The Division sent notices of noncompliance to the respective legislative committees as required by R.S. 49:1301. All four of these Boards also failed to respond to our request in the prior year. We recommend that the Legislature take actions to require these Boards to comply with the law.
- *Inactive Boards* We identified 11 inactive Boards that were not fulfilling their established functions. We recommend that the Legislature consider abolishing these Boards. Five of these Boards were also identified as inactive in the prior year.
- **Database Not Updated** Information available through the Division's website may not be up-to-date regarding Board members' salaries, travel expenses, or per diem expenses related to the fiscal year ended June 30, 2016. According to the Division, the website database fields were updated for the fiscal year 2017 reporting period to require that Boards indicate the fiscal year of the information entered; however, information reflected in the database for the fiscal year 2016 reporting period should not be used without first confirming the information directly with the respective Board. We recommend that the Division continue to work with our office regarding the form and content of the database fields to ensure information entered is properly reported and maintained. We will meet with the Division periodically to monitor the updates to the website database fields.

Trends

This report identifies 458 Boards as of June 30, 2016 (see Appendix B), which is a net decrease of 13 from the previous year. This net figure reflects an increase of five and a decrease of 18 Boards during the current year. As noted below, the total number of Boards has decreased by 34, or 6.9%, over the past five years:

In addition, Louisiana exceeds the number of Boards in other Southeastern states. Links to the other Southeastern states' websites providing information on their Boards can be found in Appendix C.

Boards Providing No Response

R.S. 24:513.2(F) directs all agencies, boards, commissions, and departments of the state and its political subdivisions to furnish information and reports as requested by the Legislative Auditor to fulfill his responsibilities. All Boards were requested to provide contact information, membership information, and statutory or legal authority relative to the entity.

R.S. 39:1335 and 1336 require licensing agencies to provide summary and detailed information pertaining to actual and budgeted revenues by source, expenditures by category, and fund balances; performance indicators; and certain general information pertaining to the Board and its authority and functions.

All other Boards were requested to provide similar information, except that the financial and budget information was requested in summary form only, and information pertaining to performance indicators was not requested.

As of June 30, 2016, we identified the following four Boards that did not respond to our request for personnel data and financial information. All four of these Boards also failed to respond to our request in the prior year.

1. Bayou Desiard Lake Restoration Commission
2. Grant Parish Economic and Industrial Development District Board of Commissioners
3. I-12 Retirement District Board of Directors
4. Vermilion and Iberia Railroad Development District Board of Commissioners

A joint letter from the Legislative Auditor and the Commissioner of Administration requesting information was mailed to all 458 Boards identified in our report. Numerous attempts to contact those Boards that did not submit the requested information were made by the Division's staff, with no response from these entities.

In accordance with R.S. 49:1301, the Division sent notices of noncompliance to each Board that failed to respond to its requests. In addition, notices of each entity's failure to respond were sent to the state departments of which the entity is a part, the Senate Committee on Senate and Governmental Affairs, the House Committee on House and Governmental Affairs, and the oversight committees for each Board. The Legislature may wish to consider taking some action against Boards that fail to comply with the reporting requirements in state law.

Inactive Boards

The following 11 Boards were never fully organized; were disbanded with no plans to reorganize; were inactive; or had no funding prospects to undertake the functions for which they were established, even though the Board members may continue to meet. Five of these Boards were also inactive during the prior year. Because these entities are not fulfilling their established functions, the Legislature should consider abolishing them.

Database Not Updated

R.S. 49:1301 requires the Commissioner of Administration to establish and maintain a website containing information on Boards: <u>http://wwwcfprd.doa.louisiana.gov/boardsandcommissions</u>

In past years, comparative information on Boards' budgets, Board member salaries, travel expenses, and per diem expenses was obtained directly from the website's database and presented in our annual Boards and Commissions Report. Our Information Technology auditors

have worked with the Division to evaluate the budgetary and expense data entered in the database by Boards. We determined that the information entered in the database did not always reflect the Boards' most recent actual budgets and expenses.

The accuracy of the information is solely dependent upon the timeliness and accuracy of the Boards' data entry. As a result, anyone attempting to access information about current budgets or expenses for a specific Board may instead retrieve information that is outdated or inaccurate.

We have subsequently worked through these issues with the Division, which has updated its database entry fields to capture the required level of detail for financial information entered by the Boards beginning with the fiscal year 2017 reporting period. However, Board members' salaries, travel expenses, or per diem expenses reflected in the database for the fiscal year 2016 reporting period should not be used without first confirming the information directly with the respective Board. We recommend that the Division continue to work with our office regarding the form and content of the database fields to ensure information entered is properly maintained. We will meet with the Division periodically to monitor the updates to the website database fields.
